
The Contract Evaluation Branch

- *Evaluate bidders' good faith effort to meet the DBE goal*




MENTOR-PROTÉGÉ PROGRAM FOR CONSTRUCTION - BRIEF HISTORY

 - 8 Graduated on July 2011
- 2012 - 2nd Round
 - 7 Mentor firms participated
 - 3 New firms recruited
- 2020 - New MPP for Construction
 - MPP has the support of D4 Director and Executive Team
 - D4CON Staff involved in running the program








- **Group Mentoring** to capitalize on vertical + horizontal knowledge, connections




